

HOW TO SIGN UP FOR FCA AFFILIATE PROGRAM

*** PLEASE NOTE: You may already qualify through your employer- Check for Affiliate Qualification though your employer by going to <https://www.fcausaffiliates.com/#eligible> and typing in your employer. If your employer qualifies, please skip to STEP 3 in the process. Please Note: you must be a current employee at the time of delivery and must provide proof of employment, such as a paystub. ***

STEP 1: Sign up for a \$100 Membership at TreadLightly at

STEP 2: After signing up, you must wait at least 30 days before making a purchase.

*It is important to note, if you are factory ordering a vehicle you DO NOT need to wait 30 days before placing an order, just make sure you sign up **ASAP!***

All membership benefit information will be included in this packet. You will also receive a digital copy of your membership letter in addition to the physical copy.

Please note that according to FCA US policy, you must be an individual \$100 member for at least 30 days to qualify for the FCA US Affiliate Rewards new vehicle discount and you must provide a copy of your membership letter to your dealer to use the discount.

*Benefits for \$50 and above members are valid only to purchases made in the US! If you are an international member and would like to receive a t-shirt, please call us at 801-627-0077.

All memberships are non-refundable. All purchases are final. PLEASE CHECK WITH YOUR DEALER TO CONFIRM WHAT VEHICLES ARE COVERED UNDER THE FCA DISCOUNT. Once a packet is sent out digitally or physically, we cannot refund it.



- 1 Get Control Numbers.**
Generate a number now and get up to two of these discount codes each year.
- 2 Visit a Dealership or the FCA US Brand vehicle E-Shop.**
Take your Control Number and proof of eligibility to a participating dealership, or use them in the FCA US Brand vehicle E-Shop.
- 3 Save Hundreds!**
Buy or lease an eligible new vehicle at 1% below dealer invoice.†

These unique discount codes are needed to unlock Affiliate Rewards Preferred Pricing† at the dealership. You can get up to two Control Numbers each calendar year. Control Numbers must always be generated in the eligible employee's name, but spouses and surviving spouses may also use the Control Numbers.

STEP 4: Request a *Control Number* via the **“Get Control Number”** button on the homepage. (you will need to be logged into your account).

****Please Note - Control Numbers are valid for 30 days so do not request one until time of your vehicle delivery/contracts****

STEP 5: Provide your *AR Control Number* and a copy of your *Tread Lightly Membership Letter* at the time of delivery for your new vehicle.

(*Tread Lightly* will mail you a physical copy and email you a copy as well - the letter must show at least 30 days elapsed from your membership join date.)
